

Six-Monthly Statistical Bulletin for the Office of the Police Ombudsman for Northern Ireland, April - September 2012

Notes

The following tables provide data on the work of the Office during the period 1 April 2009 and 30 September 2012, and include details of all complaints and allegations input up to 21st October 2012.

It is important to note that this data is extracted from the Office's 'live' Case Handling System, and may therefore be subject to future revisions. We have however endeavoured to ensure the factual accuracy of the collection of this information.

Glossary of terms

Informal Resolution

Informal resolution is offered to complainants of less serious allegations, e.g. rudeness or incivility. This process involves a senior police officer speaking to both the officer (s) involved and the complainant with a view to reaching satisfactory resolution of the complaint.

Local Resolution

Local Resolution was piloted in PSNI D District from June to November 2010. The Police Ombudsman was concerned that less serious complaints were not being dealt with expeditiously and effectively at source and this was impacting on complainants' satisfaction with, and confidence in, both police and the police complaints system. Local Resolution gave back the responsibility of dealing with these complaints to first line managers in the PSNI whilst the Office maintained a monitoring role.

Processing of new complaints received

When a complaint is made to the Office of the Police Ombudsman, it is received by the Initial Complaints Office (ICO) for preliminary assessment. The ICO has the authority to close complaints which are not suitable for formal investigation, for example, those which lie outside of the Office's remit. Where an investigation is deemed necessary by the ICO, the complaint is then passed to an investigations team for thorough

examination of the available evidence. The investigations teams' then works towards closing each allegation with a recommendation.

Recommendations following allegations closed

When the investigation of an allegation is complete a recommendation for allegation closure is made. It should be noted that one allegation may have more than one associated recommendation, for example, when there are a number of police officers linked to an allegation.

Recommended Action

Includes action such as criminal charges, disciplinary charges, Superintendent's Written Warning, Advice and Guidance and less formal management discussions.

Section 55 referral

By virtue of Section 55 of the Police (Northern Ireland) Act 1998 the Police Ombudsman can investigate matters about which no complaint has been made. This is known as a Section 55 referral.
